



AD Program Growth




AD 2016-2018 Fellow Enrollment


BNNP Program Growth

CNMP Program Growth





CNMP 2016-2018 Fellow Enrollment




HM Program Growth 2007-2018










Practice track history and impact on certification:

- Originally available through 2012 with spike in certification applications for that year prior to closure
- Subspecialty requested and was granted an extension for 2014 examination
- Practice track not in place for 2016 examination resulted in 51% drop in applications from 2014
- Subspecialty requested and was granted a second practice track extension that includes the 2018 and 2020 examinations
- ~80% increase in applications received in 2018 when practice track reopened compared to 2016 when practice track was closed
- Number of potential applications received through fellowship pathway is directly related to number of programs and enrolled fellows





NCC Program Growth






NI 2016-2018 Fellow Enrollment
